/// Important information

(A) Notice!

- » <u>BMT-20-S-IVD.50:</u> The first packaging foil is not sterile: Please store outside of sterile areas. The second packaging foil is sterile.
- > Sampling should be performed under sterile conditions according to the hygiene regulations of the operating theatre or laboratory.
- > On sampling the tissue should be completely covered with liquid.
- > After inserting the sample, seal the sample tube under sterile conditions according to the hygiene regulations of the operating theatre or laboratory.
- > Manual shaking not required after sample collection.
- > Before transport, store the sample tube at room temperature.
- > Transport sample to the laboratory.
- Processing of samples using the device IKA ULTRA-TURRAX Tube Drive or IKA ULTRA-TURRAX Tube Drive P control with laminar flow.
- > The grinding time must be adapted to the form and size of the sample
- > Max. speed / Max. timer:

IKA ULTRA-TURRAX Tube Drive: scale 4, 1 min.
IKA ULTRA-TURRAX Tube Drive P control: 3000 rpm, 1 min.
